**PROPOSED GUIDELINE FOR RECOMMENDATION OF RESIDENCE VISA FOR EXPATRIATE
IN TOURISM ESTABLISHMENTS REGISTERED
WITH SRI LANKA TOURISM DEVELOPMENT AUTHORITY**

1. The main objective of tourism Industry is to create employment opportunities for the locals. However, if there is a necessity for tourist establishments registered with Sri Lanka Tourism Development Authority to obtain services of professional expatriate in Travel, Tourism & Hospitality Industry, will be recommended to employ expatriate in specific tourism related activities.
2. The applicant/ Tourism Establishment should register and process a valid license for the current year.
3. Request for resident visa will not be entertained if the applicant is already in the country on tourist/ business visa as it contravenes Immigrants & Emigrants Act No: 20 of 1948 and its regulations and subsequent amendments.
4. Request of recommendation for visa for any category will be one year initially and extended depend on specific reasonable justification only. Otherwise the expatriate should leave the country at the end of the expiry of the resident visa.
5. Copy of the valid agreement/ contract with all relevant details such as Contract Period, Remuneration, Accommodation etc. signed by the respective establishment and expatriate to be submitted.
6. The expatriate not allowed to change the place of work, nature of work mentioned in the agreement/ contract submitted to SLTDA.
7. The person to be employed other than Investor/ Director category should possess suitable qualifications and experience in the relevant area of the work. Certified copies of qualification and experience should be submitted.
 - 7.1 All projects with Foreign Direct Investment should submit relevant documents to the One Stop Unit and obtain prior approval for commencement of the project.
 - 7.2 If the request is for an Investor or Director Category and project approved by BOI the request for residence visa will not be entertained by Sri Lanka Tourism Development Authority.
 - 7.3 If the request is for an Investor or Director Category from Foreign Direct Investment and not approved by the BOI, the application should comply with following.
 - 7.3.a Business/ Company Registration, Company Articles, Documents regarding Formation of Board of Directors and Names of the Directors should be submitted.
 - 7.3.b Minimum investment should be Rs. 20 Mn. and recommendation of visa will be restricted for Two (02) Investors/Directors only.

- 7.4 The investment should be certified by the Chartered Accountant/ Auditor with detailed bank statements and audited accounts.
8. Consultants for any specific specialized work will be recommended only for three (3) months on submission of valid qualification and experience certificates.
9. Consultant for the mega tourism related projects will be recommended for visa depends on the specific requirements and the duration.
10. Recommendation of visa for Volunteers to work in tourism activities will considered only for the specific period mentioned in the request letter from the university, collage, institute. Volunteer should not be remunerated.
11. Recommendation of visa for Musician or Dancers will be recommended initially maximum of three (3) months and could be extended depend on the requirements.
12. Recommendation of Visa for an animator should submit certified copies of certificates of experience in same filed.
13. The resident visa will be recommended for the spouse and the children under 18 of the expatriate on request.
- 13.1 Request for visa for spouse should be supported with the valid Marriage Certificate
- 13.2 Request for children under 18 should be supported with the valid Birth Certificate.

14. The following categories as per the relevant tourist establishment are proposed for recommendation of visa.

16. Application for the recommendation of visa for expatriate should be submitted at least two weeks prior to expected date of arrival.

17. Application for an extension should be submitted one month prior to the expiry of existing visa.

18. Renewal Visa of certain categories will be done on case by case basis depending on the requirement.
