SUMMARY

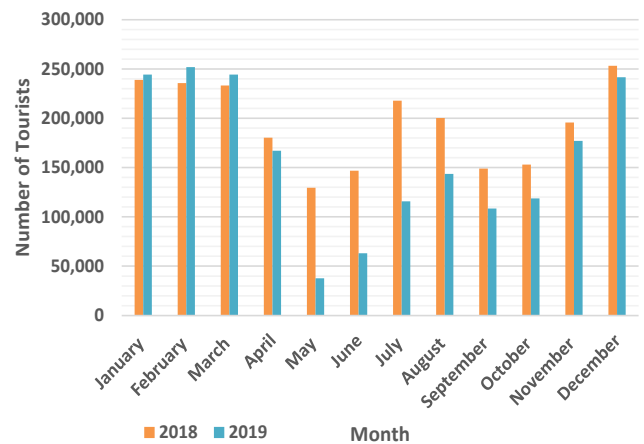
The total number of international tourist arrivals to Sri Lanka during December 2019 was 241,663. In comparison to December last year, there was a decline of 4.5% when the arrivals were 253,169.

This month, the largest source market for tourists was India, followed by the United Kingdom and Russian Federation.

Almost 93 % of tourists travelled by air to Sri Lanka.

As at 31st December 2019, 1,913,702 of tourists had visited Sri Lanka for this year. It is a decline of 18% over last year when 2,333,796 of tourists has visited the country during the same period.

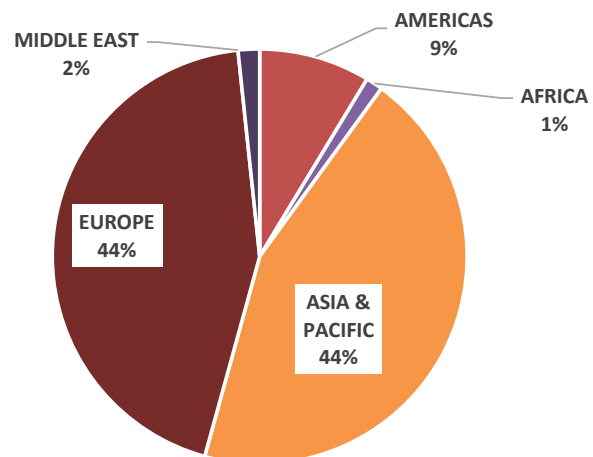

TOURIST ARRIVALS BY REGION

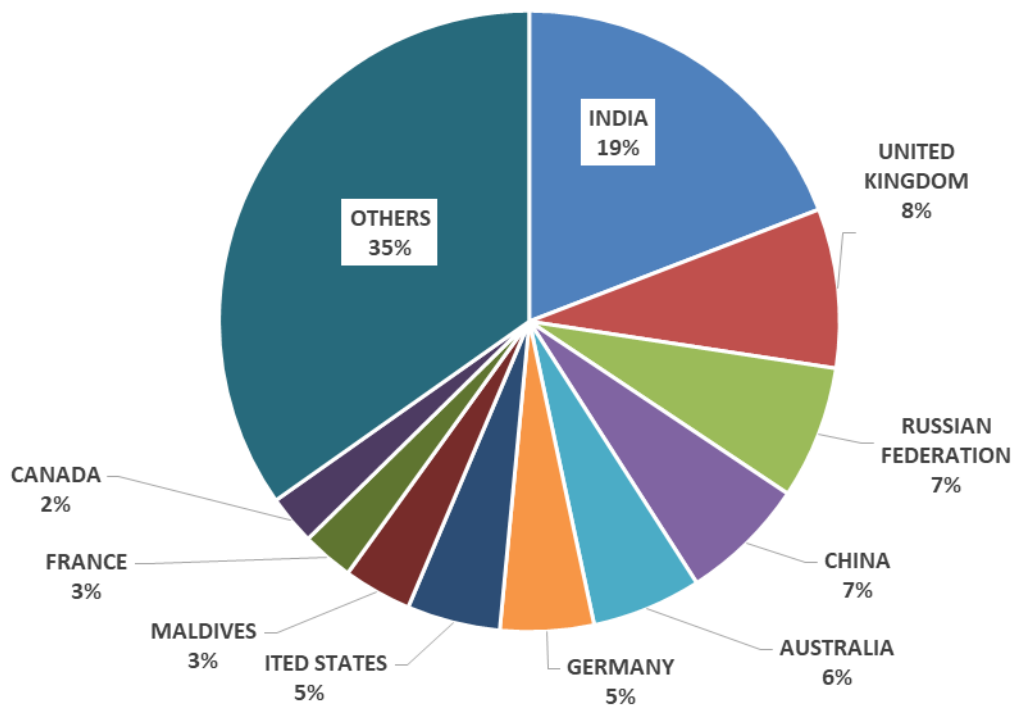
Europe and Asia & Pacific became the largest sources of tourist traffic to Sri Lanka both recording 44% (both 44%) of the total traffic received in December 2019.

Americas accounted for 9% of the total traffic, Middle East 2% and Africa 1%.



TOP TEN SOURCE MARKETS – MONTH OF DECEMBER – 2019

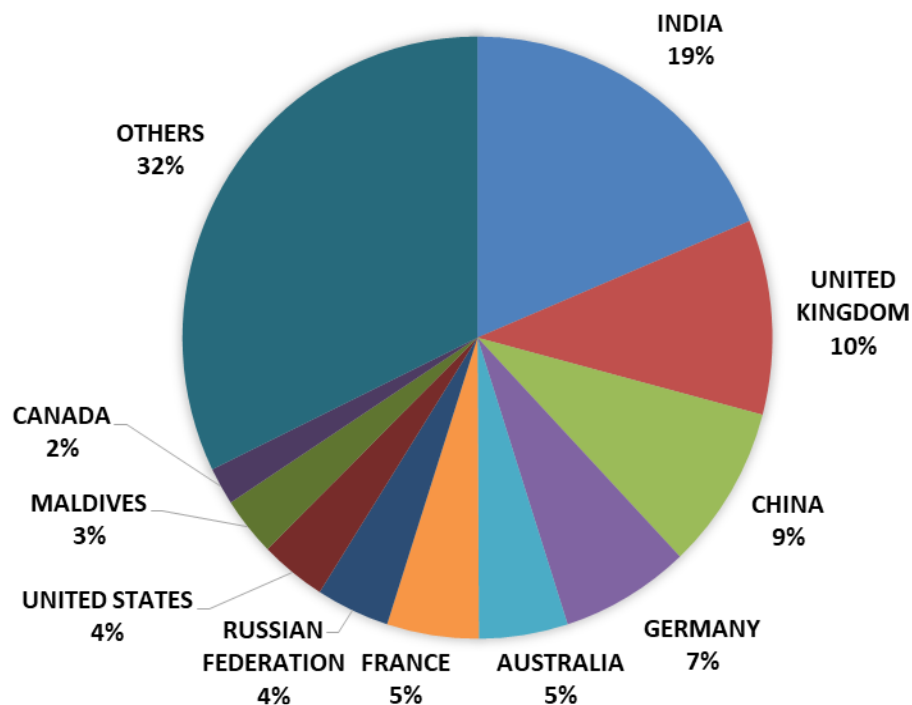
India, United Kingdom, Russian Federation, China and Australia were Sri Lanka's top five international tourist generating markets in the month of December this year. India was the largest source of tourist traffic to Sri Lanka with 19% of the total traffic received in December 2019. UK accounted for 8% of the total traffic; while Russian Federation, China and Australia accounted for 7%, 7% and 6% respectively.
