Palladium is seeking applications from qualified Non-Governmental Private Sector (registered) businesses to implement, as recipients, for the COVID-19 Emergency Economic Relief Program (Tourism Sector only) under "USAID/Sri Lanka Private Sector Development (PSD) activity". Palladium is implementing this Project under contract with USAID Contract Number: AID-7200-AA-19-C-0-0080.

Grants will be administered in accordance with USAID regulations as applicable.

Subject to availability of funds, Palladium intends to issue multiple grant agreements based on the gualifications below up to a maximum award of \$50,000 per applicant for immediate emergency relief. Payment under these agreements will be made either directly by Palladium under in-kind grants or based on the achievement of milestones under a Fixed Amount Award (FAA) grant agreement.

To be eligible for award, Applicants must provide all required information in their application, including the requirements found in any attachments to this RFA. Applications that are submitted late, incomplete or are non-responsive will not be considered. Completed applications will be reviewed beginning on August 21, 2021 through the deadline of August 31, 2021 on a



rolling, first come-first served basis. Awards will be made to the responsible applicants whose application best meet the requirements of this RFA and the evaluation criteria contained herein.

# I. Program Description

<u>USAID CATALYZE</u> is a global umbrella contracting mechanism designed to facilitate partnerships and craft solutions to mobilize \$2 billion in blended private sector and other financing to USAID partner countries. The program can work in any development sector or region, enabling USAID Bureaus and Missions around the world to efficiently facilitate investment solutions that respond to the needs of specific sectors, issues, and geographies and leverage private sector financing to achieve development objectives.

USAID/CATALYZE Sri Lanka Private Sector Development (PSD) Activity is a 5-year, \$19.5 million activity under CATALYZE that will drive increased competitiveness, financing, and economic opportunity of small and medium sized enterprises (SMEs). The activity will focus on expanding employment and entrepreneurship of women within target sectors and supply chains. The activity will provide technical assistance to SMEs, both directly and through business advisory service (BAS) providers, to build capacity, upgrade technology, access new markets, and strengthen the pipeline of bankable deals. As opportunities present, PSD will work with local institutions to provide transaction advisory services to facilitate large inbound investment. The PSD activity, will also boost resilience and adaption of SMES to the second order impacts of COVID-19, enabling firms to adapt and recover.

In order to counter COVID-19's effects on Sri Lankan livelihoods, rapid response is essential given the deteriorating financial positions of **Tourism Micro-Small-Medium Enterprises (MSMEs)** and the difficult decisions they face on retaining their employees and maintaining operations.

This specific RFA is aimed exclusively at providing economic relief to tourism businesses to help them stay afloat and not go permanently out of business during the COVID-19 pandemic. As such, all RFA respondents must meet <u>ALL</u> of the following three criteria:

- The business is categorized as a Micro, Small, or Medium Enterprise (MSME) a forprofit enterprise with less than 300 employees and/or annual revenue of less than 750 million LKR in FY 2018-19.
- 2. The business operates in the **tourism** sector; AND
- 3. The business has been in operation for a **minimum of three years**.

# Expected Results

The expected results of these relief funds are to assist Tourism MSMEs to mitigate lost revenue due to COVID-19, retain employees, to stay operational through the pandemic period.

## Definitions

Micro, Small, or Medium Enterprise (MSME) – a for-profit enterprise with less than 300 employees and/or annual revenue of less than 750 million LKR.

## Description of Funding



Subject to availability of funds, Palladium intends to issue multiple grant agreements based on the qualifications below up to a maximum award of \$50,000 per applicant for immediate emergency relief. Payment under these agreements will be made either directly by Palladium under in-kind grants or based on the achievement of milestones under a Fixed Amount Award (FAA) grant agreement.

Applications could request support for the following expenses, (applicants may apply for one, some, or all of the types of support for a maximum assistance award of \$50,000):

- 1. Salary Support: 75% of last drawn basic monthly salary OR maximum LKR 75,000/per permanent employee, whichever is lower.
- 2. Asset Refurbishment or repair: Refurbishment/Repair/Renovation of assets relevant to the operation. **PSD will NOT pay for new construction, unit additions, or property extensions**<sup>1</sup>.
- 3. Sales Promotion and Marketing: Marketing content (photography, video, branding); Costs of advertisements. **PSD will NOT pay for social media marketing**.
- 4. Health and Safety: Cost of adopting COVID-19-specific health and safety practices (face masks, hand sanitizer, gloves, PPE kits, face shields, increased cleaning in line with WHO guidance, etc.).

## II. Award Information

# A. Form of Grant

As a result of this RFA, Palladium intends to issue multiple grant agreements up to a maximum award of \$50,000 per agreement. Payment under these agreements will be either made directly by Palladium under in-kind grants or based on the achievement of milestones under a Fixed Amount Award (FAA) grant agreement.

# B. Duration

Awards will be for a period of performance of three to six months from the date of the grant award.

PSD will not consider applications that include construction alteration, or repair (including dredging and excavation) of buildings, structures, or other real property and includes, without limitation, improvements, renovation, alteration, and refurbishment. The term includes, without limitation, roads, power plants, buildings, bridges, water treatment facilities, and vertical structures.

<sup>&</sup>lt;sup>1</sup> PSD considers asset refurbishment and repair to include the following: non-structural, cosmetic work, including painting, floor covering, wall coverings, window replacement that does not include changing the size of the window opening, replacement of plumbing or conduits that does not affect structural elements, and non-load bearing walls or fixtures (e.g., shelves, signs, lighting, etc.). Major repair to roofing and flooring is considered "structural", and cannot be considered for funding.



# **III. Eligibility Requirements**

Tourism SMEs that wish to respond to this RFA must meet the following minimum eligibility criteria and provide corresponding supporting documents:

- 1. Must be categorized as a Micro, Small, or Medium Enterprise (MSME);
- 2. Must operate in the tourism sector;
- 3. Must have been in business for a minimum of three years
- 4. Must be a registered legal entity in Sri Lanka (copy of Articles of Association, copy of Company Registration Certificate and Form 1 must be attached);
- 5. Must not be debarred, suspended, excluded or otherwise ineligible to receive US Federal funding.

# **IV. Application Review**

# 1. Review and Selection Process

Sri Lanka PSD Evaluation Committee will evaluate the responses of applicants according to the Evaluation criteria noted below.

# 2. Evaluation Criteria

Applicants will be scored against the following criteria:

1.	Justification of how COVID-19 has negatively impacted the MSME; please include financial (sales, revenue, employment) information where applicable	40 points
2.	Ratio of jobs supported to total cost of grant	40 points
3.	Evidence of how the grant award will support the business to adapt to post- COVID economic realities to get back on track for the future	20 points

## V. Award Administration Information

## 1. Award Notices

Upon USAID approval, selected grantees will receive a notice of award signed by the Palladium PSD Team Lead or CATALYZE Chief of Party as the authorizing document.

## 2. Reporting

Grantees must comply with monthly reporting. Monthly reports will provide progress updates on how funds have been helping the grantee. Reports will be submitted electronically to the Sri-Lanka PSD Grants & Procurement.

## 3. Branding and marking standards

The successful applicant must follow the mandatory standard provision entitled MARKING AND PUBLIC COMMUNICATIONS UNDER USAID-FUNDED ASSISTANCE (July 2015) in preparing the Branding and Marking Plan.

## 4. Environmental compliance

The Project will conduct an Initial Environmental Examination or Environmental Assessment where the proposed activity or investment activity may directly affect the environment, to ensure compliance with 22 CFR 216 and the USAID Environmental Guidelines.
