B. Possession of a National Vocation Qualification (NVQ) not less than the level seven (7) proficiency certificate issued by a technical or vocational training institution recognized by the Tertiary and Vocational Education Commission related to the above subject areas.

AND

Minimum of 01 year post-qualifying experience in the subject area relevant to the post.

1. Must meet the qualifications for external applicants mentioned above.

OR

2. Completion of a minimum of five (5) years of satisfactory service in a post relevant to the field at the Junior Manager (JM 1-2) Grade II service category.

C. Completion of a Tertiary and Vocational Commission recognized course in Computer Word Processing/ Typing or equivalent qualification would be an additional qualification.

#### ***For Internal Applicants***

Can apply Primary Grade – Non-Skilled, Semi-Skilled and Skilled Service Category Employees with the following qualifications;

- A. Passing six (06) subjects, with credit passes in four (04) subjects, including Sinhala/ Tamil, Mathematics and English in the G. C. E. (O/L) Examination.

- B. Permanent appointments in the service should be held and those appointments should be made permanent.
- C. Five (05) years of continuous satisfactory service must have been completed by the permanent applicant prior to the due date.
